RE: PUBLIC COMMENTS

There were no comments.

RE: PROPOSED BUDGET

Mr. Doss presented the revised FY24 budget that included the Board's requested increase in the nurses' salary to \$60,000.00 and the resulting increase to the member localities' contribution. Mr. Doss asked that the budget be approved. A discussion ensued. A motion was made by Mr. Koontz and seconded by Ms. Seay to approved the budget as presented in the amount of \$8,634,321.000. Motion passed.

RE: APPROVAL OF MINUTES

A motion was made by Sheriff Walton and seconded by Sheriff Bushey to approve the January 4, 2023 minutes with corrections. Motion carried.

RE: FINANCIAL REPORT

There were no comments.

RE: SUPERINTENDENT'S REPORT

Mr. Doss informed the Board that the shower project is in its final phase.

Mr. Doss asked the November meetings be changed to the second Wednesday. A motion was made by Mr. Koontz and seconded by Mr. Akers. Motion passed.

Mr. Doss informed the Board that the current ADP was 150.

Mr. Doss disclosed that the facility has had an increase in inmate medical costs.

Mr. Doss informed the Board that VARJ (Virginia Association of Regional Jails) was successful in adding a retired superintendent to the Board of Local and Regional Jails. The Board of Local and Regional Jails wants to be notified if a released inmate passes away. If an inmate comes in with a serious medical issue and is released, the Board of Local and Regional Jails wants to track that inmate in case he/she passes so they can see if it was caused by their time spent incarcerated.

Mr. Doss reminded the Board that the discussion of elimination of commission from the inmate phone and commissary sales is active in the Senate. There is also discussion of changing the per diem from \$4 to \$8 to compensate for the lost revenue.

Mr. Doss advised that Senator Deeds is trying to dissolve sovereign immunity for correction officers.

Mr. Doss informed the Board that the Department of Corrections will no longer be sending Work Release inmates to the facility.
