BOARD MEETING

Minutes from May 3, 2023

The meeting was called to order at 9:00 a.m. by Chairman Sheriff Barrick at the Middle Peninsula Regional Security Center conference room, Saluda, Virginia.

RE: PUBLIC COMMENTS

There were no comments.

RE: APPROVAL OF MINUTES

A motion was made by Sheriff Walton and seconded by Mr. Akers to approve the February 1, 2023 minutes with corrections. Motion carried.

RE: FINANCIAL REPORT

Ms. Kinser informed the Board that the Department of Criminal Services had awarded regional jails with an equipment grant using ARPA funds. The amount of the grant was \$25,000 plus \$1,500 per certified correctional officer per facility. The amount of the grant for the facility will

be \$104,500. A motion was made by Mr. Koontz and seconded by Mr. Akers to appropriate the grant in the amount up to \$104,500 for FY23. Motion passed.

Ms. Kinser announced that she has received the final draft of the Financial Statement for FY22 and should be receiving the complete Financial Statement within the next few weeks.

There were no comments in reference to the March financial report.

RE: SUPERINTENDENT'S REPORT

Major Bristow announced that the facility will be having gun qualifying from 8am-12pm on September 25-29, 2023, if any of the sheriff's departments wants to join them.

Mr. Doss advised that we had our annual surprise DOC audit. We had two (2) deficiencies: one involved items not on the dental inventory list and the other involved items not on the kitchen inventory list.

Mr. Doss informed the Board that our ADP is extremely low. He explained that the number was around 117 and that we had about 25 inmates from Northern Neck Regional Jail. Mr. Doss informed the Board that he is working on housing DOC responsible inmates for another jail so we do not lose funding for the emergency positions from the Comp Board. He explained that we currently have three (3) officer and two (2) nursing positions vacant.

Mr. Doss congratulated his nursing staff for a job well done. The facility had an inmate arrive at the facility and the nurse noticed a knot on her neck during the evaluation. After seeing the doctor, it was decided to have the knot tested and the inmate has stage 4 cancer. The court granted a modified release for the inmate.

Mr. Doss informed the Board that he would be going on May 17th to the Local Board of Regional Jails meeting about death investigations. Mr. Doss explained the death review process.

Mr. Doss advised that the facility has had issues with the doctors from the mental health facilities releasing inmates back to MPRSC with instructions saying not to send the inmates back to the mental health facilities. Mr. Doss described the need for us to send at risk inmates to mental health facilities despite these instructions.

Mr. Doss informed the Board of the increased salary and bonuses for Gloucester County jail officers. Mr. Koontz asked Mr. Doss to a keep a spreadsheet of the changes to the salaries so that it can be tracked better.

Mr. Koontz left before going into closed session.

RE: BUSINESS BROUGHT UP BY AUTHORITY BOARD MEMBERS

There was no business brought up.

RE: CLOSED SESSION

A motion was made by Mr. Akers and seconded by Ms. Seay to enter into closed session, pursuant to section 2.2-3711(A) (1) of the Code of Virginia for a discussion of personnel matters involving Mr. Doss's evaluation. The motion carried unanimously.

RE: RETURN TO OPEN SESSION AND CERTIFICATION OF CLOSED MEETING
