SPECIAL BOARD MEETING

Minutes from August 17, 2023

The meeting was called to order at 1:01 p.m. by Chairman Sheriff Barrick at the Middle Peninsula Regional Security Center conference room, Saluda, Virginia.

RE: STAFF VACANCIES

Superintendent briefed the Board about the large number of officer positions that are currently vacant and the effect the vacancies have on officer safety and operational effectiveness. As of today, the facility has ten (10) officer positions open with one (1) new officer starting the next week and four (4) more officers to leave in the next few months. The facility is experiencing a low quality of applicants and we have relaxed our criteria for hiring. We are also hiring civilians for full-time main control operators and retirees for officers on a part-time basis to fill the gap. Mr. Doss explained that it is difficult to get accurate hiring salary information for our surrounding localities and agencies. Mr. Doss requested that we raise our salaries by \$5,000 for each sworn position, bringing our hiring salary for noncertified officers to \$49,000 per year and for certified officers to \$52,000 per year. A discussion ensued. A motion was made by Mr. Koontz and seconded by Sheriff Bushey to add \$5,000 to all sworn positions and to

adjust the starting salaries. Motion passed 6:1 with Sheriff Balderson voting in the negative.

RE: CLOSED SESSION

A motion was made by Mr. Koontz and seconded by Sheriff Walton to enter into closed session pursuant to Section 2.2-3711(A)(1) of the Code of Virginia for discussion of a personnel matter involving a Sergeant at the jail. The motion carried unanimously.

RE: RETURN TO OPEN SESSION AND CERTIFICATION OF CLOSED MEETING

Code Section (Reason): Section 2.2-3711 (A) (1) Personnel Matters involving the performance of a Sergeant at the jail.
