RE: ELECTION OF OFFICERS

A motion was made by Sheriff Holmes and seconded by Mr. Akers to elect Ms. Seay as Chair and Sheriff Balderson as Vice-Chair. Motion carried.

RE: APPROVAL OF MINUTES

A motion was made by Mr. Akers and seconded by Sheriff Balderson to approve the August 17, October 4 and November 8, 2023 minutes. Motion carried.

RE: FINANCIAL REPORT

Ms. Kinser asked to appropriate the generator from FY 25 to FY 24 because it has failing components. A discussion ensued. A motion was made by Mr. Akers and seconded by Sheriff Balderson to start the RFP. Motion carried. Mr. Doss explained that the heat failed, but has been fixed.

RE: FY25 BUDGET PRESENTATION

Mr. Doss presented the FY25 budget. A discussion ensued. A motion was made Mr. Hodges and seconded by Sheriff Balderson to approve the budget as presented in the amount of \$9,732,470 with the salary qualifications being held until after the localities decide on their raise percentage. Motion carried.

RE: SUPERINTENDENT'S REPORT

Mr. Doss informed the Board that the facility is working on increasing their work release program and inmate population. The inmate population is down and there are several inmates that will be going to Department of Corrections in the coming weeks.

Mr. Doss announced that is has been appointed to the Board effective July 1st, 2024.

Mr. Doss welcomed the new members and let them know that he could do a tour today or any day that was convenient for everyone. He also let the Board know that he could be reached by cell anytime.
